On 6 November 2017, an ordinary resolution to approve the share consolidation was passed by the shareholders at a special general meeting whereby share consolidation became effective on 7 November 2017 that every five (5) issued and unissued ordinary shares of HK\$0.01 each was consolidated into one (1) consolidated share of HK\$0.05 each (the “Share Consolidation”).

2. Upon effective of Share Consolidation as above-mentioned per remark (1), the exercise price of the outstanding share options and the number of consolidated shares to be allotted and issued upon full exercise of the outstanding share options was adjusted in accordance with the terms of the share option schemes adopted on 24 May 2002 and 17 May 2012. All outstanding share options under the share option scheme adopted on 24 May 2002 were lapsed on 12 November 2017.
